Behaviour of Sexual Offenders



Karen Holt is an Assistant Professor in the School of Criminal Justice at Michigan State University, whose research focuses on sexual deviance and offending and the intersection of media and sexual violence. Her work has been published in scholarly journals such as Violence and Victims, Sexual Abuse, and The Journal of Behavioral Medicine. She is a member of several professional associations, including the American Society of Criminology, The Latina Researchers Network, The Center for Gender in Global Context, The Research Consortium for Gender-Based Violence, and the Association for the Treatment of Sexual Abusers (ATSA). She is a board member of the Michigan chapter of ATSA and Small Talk, a children's advocacy center in Lansing.

Project Porsche



In July 2020, a female went for a walk in her Durham neighbourhood. When she didn't return home her husband searched for her but could not locate her. The Durham Police were called, and a missing person investigation commenced. The female was brutally sexually assaulted by a stranger and for 13 hours she was left naked in a creek bed less than a km from her home. As a result of a thorough investigation which included media releases and video surveillance, the offender was identified. This is Kimberley's story of resilience, the investigation that led to the capture of the offender, and an exploration into the criminal mindset of a sexual predator.

Human Trafficking Survivor



Jasmine is a recognized expert in human trafficking and has significant experience educating frontline workers, government leaders, the court system, law enforcement, community agencies, and the public to provide insight into the issue of human trafficking and information on how to better understand, support, and work with survivors.



Ottawa Police Child Abuse Unit investigation where they had a young non-verbal child disclose that they were sexually assaulted. The presentation will highlight statement admissibility and the crown's prosecution. R vs Walker.

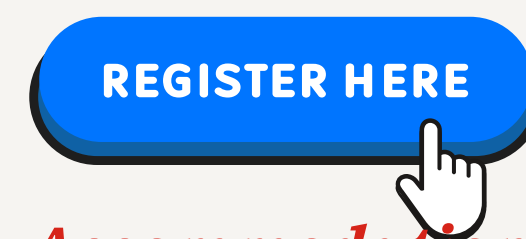


Peel Regional Police Human Trafficking Unit investigation where the accused (R vs Campbell) trafficked 2 females over the course of 7 years. The girls made an estimated \$3 million, accumulated/flipped properties, resided together with Campbell (collectively), helped to raise his children, socialized only with him and other Pimps/stws. Both managed to break free of him after 7 years (staggered) and when he had acquired another girl. Ultimately charged with 26 offences.

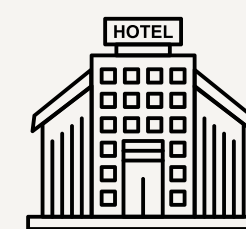
